It is the intention of the road commission, as the weather warms up within the next couple of weeks, to do some ditch cleaning and culverts repairs on Peterson Rd. Also, a petition for a county drain has been submitted to the county drain commissioners office. The township is engaged in looking at various options to help alleviate any future water issues on Peterson Rd.
