### 2018 March Board Of Review— How to Appeal Your Assessment

It's that time of year again, when annual assessment notices are mailed to all property owners with the proposed values for the upcoming year (2018).

If you do not agree with the proposed 2018 values, property classification or any transfer of ownership for your property you may appeal to the Board of Review. Appealing to the Board of the Review is required by State law to reserve your right to appeal (if needed) to the State Tax Tribunal.

Appeals are made by making an appointment with the Board of Review and completing the petition form L-4035 which is available at your appointment or online at:

Call 231-744-2454 to make an appointment with the March Board of Review.

If you are unable to appear in person, **you may appeal by mail**—you must complete the L-4035 form and mail it to Laketon Township with your letter and any facts to support your appeal. The form and your appeal letter with any supporting documentation **MUST** be received by Laketon Township **BEFORE** the close of the March Board of Review at 9:00 PM on 3/13/2018.

If you have any questions about your assessment notice or making an appeal/appointment, please call Laketon Township for assistance. Regular office hours are Monday thru Friday 8:30 AM to 4:30 PM.

The Assessor is in the office on Mondays, Tuesdays and Wednesdays only from 8:30 AM to 4:30 PM.

### Snowmobiles are Prohibited on Bike Paths & Sidewalks

While this is a "spring" newsletter, we may still have some days left that involve winter temps and snow—which also often means snowmobiles.

Snowmobiles have been a bit of a problem this year with regard to bike paths and sidewalks. These paths are not intended for motorized vehicles of any kind, in fact, while they are commonly referred to as bike paths, they are more correctly designated as non-motorized trails. These

trails were designed for pedestrians and bicycles only. Snowmobiles & other motorized vehicles are hazardous to the pedestrians & cy-

clists using them.

Laketon Township has a Sidewalk and Pedestrian Path Ordinance regulating the use of these trails that states: "No person shall operate a snowmobile, motorcycle, moped or other motor vehicle upon any side-

walk or path within the township" This does not apply to motorized wheelchairs. The full ordinance is available on the Laketon Township Website ([www.laketon.or](http://www.laketon.or)) click on the General Township Info tab, then choose General Ordinances from the drop down menu.

### Township Ordinances—Things Every Property Owner Needs to Know!

In addition to the Sidewalk ordinance referenced above, Laketon Township has a number of other ordinances to regulate, permit or prohibit a variety of activities or conditions. There are two types of ordinances, Zoning Ordinances and General Ordinances. Ordinances are enacted to promote the safety, health and welfare of residents within the community.

Zoning Ordinance generally regulate land use and land use activities. For example, the zoning ordinance:

- PROHIBITS recreational vehicles, trailers, boats, campers etc from being stored/parked within any front yard, with the except-

temporarily for loading, unloading & cleaning (not to exceed 48 hours at a time).

- PROHIBITS residential home rentals that are less than 30 days—with the exception of some pre-existing seasonal cottages that existed legally prior to the ordinance.
- Includes many other regulations including regulations for accessory structures, clearing & filling of land, setbacks from property lines, fences and much more.

General ordinance regulate other types of activities and conditions. The things we get the most calls on relate to yard maintenance and "junk" which are covered in the Anti-Blight Ordinance.

- Anti-Blight Ordinance—regulates the keeping/storage of unlicensed vehicles, RV, misc. junk/equipment, yard waste and building materials to name a few.
- Animal Ordinance—regulates the keeping of horses, chickens and other livestock as well as sets minimum standards for keeping household dogs and cats.

### REMONUMENTATION—Taking place in Laketon Township over the next 2 years

County Surveyor Tim DeMumbrum made a presentation to the Laketon Township Board of Trustees at their meeting on February 15, 2018 regarding the state required remonumentation. Over the next 2 (two) years, as required by Michigan State Law (Survey & Remonumentation Act 1990 P.A. 345), the County Survey office will be out in Laketon Township making sure survey monuments are still in place or replacing ones that are missing.
