2012 YARD WASTE CARDS—AVAILABLE!

Even though we've had an unusually mild winter, spring weather and warmer temperatures will be here before you know it! And with the warmer weather comes the inevitable yard clean up of leftover fall leaves and branches etc.

As you know, Laketon Township offers a yard waste site for homeowners/residents to dispose of grass clippings, brush (no larger than 3 inches in di-

ameter), leaves and other garden waste. NO stumps or root balls.

In order to use this site, residents/homeowners must purchase a yard waste disposal card at a cost of \$10.00 per calendar year.

This card, in addition to helping to offset some of the cost of running the site also helps us identify authorized users and helps prevent unauthorized users & non-residents from using the site.

You can purchase your card in the office now or at the site when it opens for spring hours.

02/28/2012—On February 28, 2012, there will be an election for the Presidential Primary. Polls are open from 7:00 am to 8:00 pm. As this is a primary, you will be asked at the polls to chose whether you'd like a Republican ballot or a Democratic ballot. You may only vote for one or the other.

Important Dates to Know:

07/09/2012—this is the last day to register to vote if you wish to vote in the August Primary Election

10/09/2012—this is the last day to register to vote if you wish to vote in the November General Election.

March Board of Review Dates 03/12/12 & 03/14/12

This newsletter is mailed to you along with your 2012 Assessment Notice. This notice is to inform property owners of the proposed values for their properties for the 2012 year.

All property owners should review this notice carefully. This notice contains the 2011 values, the proposed 2012 values and the amount of change in the values from 2011 to 2012. It also contains information on the Principal Residence Exemption and transfers of ownership, if any occurred.

The March Board of Review is held to hear the appeals of property owners regarding their State Equalized Value (SEV). If you wish to appeal this value, you should follow the instructions on the assessment notice to make an appointment with the Board of Review. The Board of Review will hear property owners appeals on 03/12/12 between 3pm and 9pm and 03/14/12 between 9am and 3pm. REMEMBER, please bring any documentation to support your arguments! If you are unable to attend in person, you may appoint someone to represent you

or you may also appeal in writing by sending a letter and any documentation to support your appeal
