

**LAKETON TOWNSHIP  
MUSKEGON COUNTY, MICHIGAN  
STREET ADDRESS ORDINANCE  
(ORDINANCE NO. 11081802)**

At a regular meeting of the Township Board for Laketon Township held at the Township offices on August 18, 2011, beginning at 6:00 p.m., the following Ordinance was offered for adoption by Township Board Member Zaagman, and was seconded by Township Board Member Kane.

THE TOWNSHIP OF Laketon (the "Township") ORDAINS:

Section 1. Purpose. In order to ensure access by public safety personnel, and to ensure proper utility services, the Township declares that the purpose of these regulations is to ensure that the public health and safety of its residents is enhanced by designating and approving addresses for existing and future parcels of property located within the township.

Section 2. Designation. The Township Assessor shall be responsible for designating and approving all street addresses for existing and future parcels of property located within the Township.

Section 3. Approval. The owner of any parcel of property located within the Township must seek and receive the written approval of the Township Assessor before designating or using an address for a particular parcel of property.

Section 4. Use. Buildings constructed upon existing and future parcels shall have the approved address numbers placed in a position to be plainly legible and visible from the street, road, private right-of-way, alley, or easement, fronting the property. The numbers shall contrast with their background. Address numbers shall be Arabic numerals or alphabet letters. Numbers shall be a minimum of four inches high with a minimum stroke width of one-half inch.

Section 5: Repeal. All ordinances or parts thereof which are in conflict in whole or in part with any of the provisions of this ordinance as of the effective date of this ordinance are hereby repealed to the extent of such conflict, except that terms defined herein for purposes of interpretation, administration and enforcement of this ordinance only will in no way, manner or form repeal, notify or otherwise change the definition of any such terms as used in other ordinances of Laketon Township.

Section 6: Effective Date. This ordinance was approved and adopted by the Township Board of Laketon Township, Muskegon County, Michigan, on August 18, 2011, and is ordered to take effect on August 31, 2011.
